Excluded from this three year Warranty are electrical, plumbing, windows, doors, seals, sealant, paint, undercoating and fiberglass parts, interior wall liner which are warranted for ONE(1) YEAR period from the date of purchase by the Original Purchaser.

THINGS EXCLUDED FROM WARRANTY

Warrantor is not responsible for claims relating to the following: (1) trailer rental; (2) defacing: scratches, dents chips, tears, and defacing on any surface not caused by Warrantor; (3) routine maintenance; (4) damage from unauthorized repairs, abuse, misuse or neglect; (5) damage caused from improper hitch ball or tow vehicle hook up; (6) vibration, water damage, freezing breakage, or other damage to the contents of any trailer, regardless of cause; (7) component parts covered by separate Suppliers Warranty such as warranties of the manufacturer of tires, axles, jacks, couplers, windows, light fixtures, generators etc. These warranty claims must be presented to their respective component manufacturers for warranty service. Cargo Craft, Inc. reserves the right for final determination whether or not the product has been abused or misused by the Purchaser.

WARRANTOR'S OBLIGATION- HOW TO GET WARRANTY SERVICE
